**Stud Fee : \$ 1000.00 (or 3 for \$2500.00)**

This Breeding Contract, entered into on this \_\_\_\_\_ day of \_\_\_\_\_, 200\_\_ between Spencer Benedict Stables (SBS) and the undersigned mare owner ("Owner") is subject to the following terms and conditions:

1. The breeding fee shall be One Thousand Dollars (\$1000.00) or three for Two Thousand Five Hundred dollars (3 for \$2,500.00) which shall be paid in full before mare(s) can be bred.(plus 6% Sales Taxes if used in the state of Kentucky)
2. Mare(s) shall be bred artificially. Any procedures including but not limited to: cultures, hormone essays or supplements deemed necessary in order to promote conception will be implemented. The cost of these procedures will be the responsibility of the mare(s) owner(s).
3. Board bills, veterinarian bills and other necessary expenses for mare care are not part of the breeding fee and shall be paid by mare owner. It is understood that SBS may utilize the services of a veterinarian whose services will be billed to the mare owner.
4. Availability of Semen. Shipped semen and pick-ups will be made available **ONLY** after all mares on the farm have been serviced. SBS reserves the right to determine availability and distribution. Transported semen will be available on a limited first come first serve basis per the attached terms. Frozen Semen may also be available.
5. Stallions will be collected from October 15-December 15 for fall breeding season and from March 1-July 15 for spring breeding season.
6. When the designated mare has been declared safe in foal for at least 90 days, the limited live foal guarantee becomes effective. If the mare does not produce a live foal –one that stands and nurses – SBS will rebreed the mare, or a substitute, for a period not to exceed twenty four (24) months from the original due date, at no additional breeding fee.
7. Mare will be in good physical condition and free of disease and infection or may be rejected by SBS, at its sole discretion. Mare owner shall present SBS with a negative Coggins test and health papers not more than one year old upon the arrival of the mare at SBS. If not provided, one will be prepared at the mare owner's expense. If the designated mare is determined to be unfit for breeding, a substitute may be used upon approval of SBS

during the contract period. SBS may require an examination or culture from a licensed veterinarian at the expense of the mare owner. Mares left at the farm shall have current vaccinations and dewormings or will be done so at the mare owner's expense.

8. SBS shall not be liable for death, sickness, and/or accident, including consequential damages caused to the mare and/or foal.

9. Should the stallion to which you are breeding become unfit for service, or be sold, SBS shall be released from this agreement, thereby making it null and void, and the mare owner shall be entitled to no cash refund. In the event of this circumstance, the mare owner will be given credit for fees already paid toward another stallion at SBS, if the designated mare is not in foal.

10. Mare owner shall be responsible for furnishing the full and correct name and registration number of the mare to be bred. Any cost resulting in correcting name or registration number on stallion report will be the responsibility of the mare owner.

11. Mare owner is bound by the normal rules, regulations, and policies of SBS, which are incorporated herein as part of the contract.

12. The stud fee is transferable only with prior written approval from the stallion owner.

13. **A finance charge computed at a periodic rate of 1.5% per month (18% Annual Percentage Rate) is applied to past due accounts over 30 days. Owner is liable for all legal and collection fees.**
